PRIVACY POLICY

Project C2, LLC ("ProjC2", "we", "us") understands the importance of protecting the privacy of visitors to our website ("Visitors") and Visitors who have registered accounts to transact business with us ("Authorized Users") (collectively, "you", "your"). This Privacy Policy provides information on how personal information is obtained through your use of www.projectc2llc.com, or related sites, (together, the "Website"), and is processed and used on this by us and our service providers. ProjC2 uses your personal information only in ways that are compatible with this Privacy Policy. In addition to reviewing this Privacy Policy, please read our Terms of Use. Your use of the Website constitutes agreement to be bound by the Terms of Use and this Privacy Policy. If you do not agree to the Terms of Use and this Privacy Policy, you should not use this Website. This Privacy Policy does not cover information collected on sites linked to or from the Website.

Information Collected. ProjC2 collects personal information from you when you provide personal data through our Website and through automated processes. Some of the information below may be collected by one or more service providers to ProjC2 on its behalf. The following categories of information may collected, some or all of which may be considered personal information:

- (a) Identifiers and other personal information such as your name, billing address, shipping address, email address, telephone number, account number, password, user ID, mobile device IDs, and Internet Protocol address.

We reserve the right to use in any manner and also to disclose any non-personal information that we collect including, but not limited to, anonymous information including, but not limited to, cookie and traffic data. This Privacy Policy covers the use of cookies by us and does not cover the use of cookies by any advertisers. Information Automatically Collected. In addition to the categories of information identified above, we automatically receive and collect certain types of information whenever you visit our Website. For example, like many Websites, we use "cookies" and web beacons to obtain certain types of information when your web browser accesses our Website. We use this information to monitor the usage and performance of our Website, to enhance our customers' search experiences and to determine aggregate information about our user base and usage patterns.
